 PLEASE BE COURTEOUS TO VENDORS BESIDE YOU. IF YOU CAN NOT REFRAIN FROM USING FOUL LANGUAGE, YOU WILL NOT BE INVITED BACK NEXT YEAR.

You may set up during the day Friday and sell on Friday night. If you need lights or electricity, you will need to reserve an electrical space. (ELECTRICAL SPOTS ARE LIMITED)
